Read the label carefully and consult your distributor sales representative before applying this product on creeping bentgrass. Shake well. Maintain agitation during mixing and application.

Recovery Programs	COOL SEASON TURF: Spring green up and summer stress recovery: Apply 0.5 to 1.0 fl oz per 1,000 sq ft every 10 to 14 days as necessary. Aeration recovery/ New seed/ New sod: Apply 1.0 to 2.0 fl oz per 1,000 sq ft every 7 to 10 days as necessary. WARM SEASON TURF: Apply 1.0 to 3.0 fl oz per 1,000 sq ft every 7 to 14 days.
Nutrition Maintenance Programs	COOL SEASON TURF: Apply initial application of 0.5 fl oz per 1,000 sq ft. Increase as necessary in 0.25 fl oz increments. Repeat application every 10 to 14 days. WARM SEASON TURF: Apply 1.5 to 3.0 fl oz per 1,000 sq ft every 10 to 14 days.
Ornamentals	Flowers and Vegetables: 1 tbs per gal of water. Drench plants. Trees and Shrubs: Apply with root feeder in combination with regular fertilizer at a rate of 24 to 40 fl oz per 100 gal of water.
