ACTIVO is a unique activator adjuvant formulated with a green pigment to optimize pesticide performance and turfgrass appearance. ACTIVO is ideal for professional turfgrass managers seeking high quality turf, including areas such as fairways, tees, greens, sports fields, parks and commercial properties.

#### **DIRECTIONS FOR USE**

The addition of adjuvants to some pesticides and/or fertilizers and associated tank mixes may cause phytotoxicity to desirable plants. Before using ACTIVO, the applicator or crops advisor must have experience with the pesticide combination, including ACTIVO, or must have conducted a phytotoxicity test.

#### **MIXING**

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation

#### STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only.
